A Report on Two Days Online Faculty Development Programme on “Teaching Pedagogy and Research Skills” 21st March to 23rd March, 2022

St. Thomas College of Law, Greater Noida, organized two days online Faculty Development Programme (FDP) from 21 March to 23 March 2018. Based on the theme “Teaching Pedagogy and Research Skills”, the FDP became the scintillating platform of exchange of ideas and concerns among almost three generations of law academicians and practitioners. The Programme witnessed lectures by legal luminaries like Prof. (Dr.) Manoj Kumar Sinha, Director, Indian Law Institute (A Deemed University) Delhi. 
1st FDP of the St Thomas' College of Law ✓
